## Introduction

The NJ Safe Routes Resource Center (NJSRTS RC) is a partnership between the New Jersey Department of Transportation (NJDOT) and the Alan M. Voorhees Transportation Center (VTC) which is housed within the Edward J Bloustein School of Planning and Public Policy at Rutgers, The State University of New Jersey. This partnership was established to provide services, training, coordination, and technical assistance directly to regional planning associations, organizations, and local and regional governments. In 2011, the capacity of the NJSRTS RC was expanded to form a partnership between NJDOT, the NJSRTS RC, and all eight of New Jersey's Transportation Management Associations (TMAs). NJDOT provides program administration and guidance through each of the TMA's SRTS Regional Coordinators as well as provides federal funding through the Local Aid Grant program.

Working with the NJSRTS RC, SRTS Regional Coordinators from all eight TMAs are mobilized to proactively reach out to and partner with schools, local and regional governments and other organizations from all 21 counties throughout New Jersey to provide a variety of SRTS non-infrastructure services such as programs and education and implement these events and programs to encourage students to walk and bike to school. The NJSRTS RC provides support by offering services, training, oversight, and technical assistance to all eight of NJ's TMAs.

The NJ Safe Routes to School Resource Center focuses on:


- Enhancing the capacity of Transportation Management Association (TMA) staff by providing training, guidance, support, discussion opportunities, and information sharing regarding the technical aspects of Safe Routes to School;
- Encouraging increased participation in education, encouragement and enforcement activities throughout the state of New Jersey;
- Facilitating policy-level discussions to increase linkages between active transportation and public health; and
- Providing technical assistance directly to New Jersey communities and schools.

2020 marked the ninth year of the enhanced non-infrastructure program managed through the NJSRTS RC, and the program continues to develop and expand. Working with the NJSRTS RC, the SRTS Regional Coordinators have significantly increased outreach levels across the state since launch of the program in 2011, and they continue to make strides in project and program implementation as reflected in this update report.

# 1. Outreach Progress Reports

Outreach Progress Reports and maps were prepared both at the statewide level as well as for each TMA based upon information reported in the monthly Record of Contact through December 2019 and 2020. The reports detail how many and which communities the TMAs have contacted regarding SRTS programs as well as disadvantaged communities reached. Outreach reports have been generated for:

#### **Overall Statewide Outreach for 2019-2020**

Outreach from the TMAs across New Jersey for 2019 (from January through December 2019) consisted of the following:

- TMAs made contact with 167 communities or 30% of the total communities in NJ of 565.
- The total number of disadvantaged communities contacted is 32 out of 100 disadvantaged communities in New Jersey.
- The total number of school districts contacted is 21.
- The total number of schools contacted is 296.
- The total number of municipal contacts is 63.
- The total number of contacts with other organizations is 52.
- Total outreach of all types is 432.

Although the TMAs worked with existing and new partnerships through these two years, the ongoing COVID19 pandemic has influenced outreach and event participation. Outreach from the TMAs across New Jersey for 2020 (from January through December 2020) consisted of the following:

- TMAs made contact with 186 communities or 33% of the total communities in NJ of 565.
- The total number of disadvantaged communities contacted is 40 out of 100 disadvantaged communities in New Jersey.
- The total number of school districts contacted is 26.
- The total number of schools contacted is 216.
- The total number of municipal contacts is 96.
- The total number of contacts with other organizations is 90.
- Total outreach of all types is 428.

#### **Disadvantaged Community Maps**

Seven of the eight TMAs serve areas which include designated disadvantaged communities. These communities were identified as important outreach targets to encourage SRTS participation. Regional Coordinators have been instructed to provide enhanced outreach efforts to disadvantaged communities in their service areas. The statewide maps show the disadvantaged communities reached and whether outreach levels were initial contacts or program implementation. The disadvantaged community maps indicate both disadvantaged communities contacted and not contacted by each TMA within each of their service areas in 2019 and 2020.

Outreach and engagement with disadvantaged communities is prioritized in the SRTS program. The NJ SRTS RC uses the New Jersey Department of Education's (NJ DOE) District Factor Group (DFG) designation based on a community's approximate socioeconomic status. The DFG designations used in this report are from the 2000 decennial census, which is the most recent date they were updated. The following six variables which are closely related to socioeconomic status are used to calculate the DFGs:

- 1. Percent of adults with no high school diploma
- 2. Percent of adults with some college education
- 3. Occupational status
- 4. Unemployment rate
- 5. Percent of individuals in poverty
- 6. Median family income

Using these six variables, each municipality is given a score. This score may be weighted if some communities receive a significant share of students from other communities. Districts with similar scores are grouped into a DFG class. The eight DFG classes are A, B, CD, DE, FG, I, and J. Municipalities ranked A or B (the lowest DFG scores) are considered "Low Socioeconomic Communities" or "Disadvantaged Communities" for the purpose of the SRTS program.

#### **Outreach Observations for each TMA**

The outreach section of each TMA's report is a summary for 2019 and 2020 of:

- The total number and percentage of communities the TMA has reached during each year;
- The total number of contacts at the district, school, municipality, organization, other and total contacts at all levels each year;
- The total number of disadvantaged or low-socioeconomic status communities contacted in the service area, as well as the number and names of the disadvantaged or low-socioeconomic communities not contacted each year.

#### **Table of Contacted Municipalities**

The report shows a table listing the name of each municipality contacted by county and the type of entity contacted for 2019 and 2020. Outreach has taken place at various levels in each community—school, school district, municipality, or other community organization. Disadvantaged communities are indicated with an asterisk.

#### Outreach Levels from January through December of 2019 and 2020 for each TMA

The report displays a pie chart showing the assessed outreach at all levels (school, district, municipality and other organizations) for the months from January through December of 2019 and 2020 which are detailed in the monthly Record of Contacts. Outreach is categorized into six classes: (1) Contact Made, (2) Preliminary Conversations, (3) Setting up a Program, (4) In the Process of Program Implementation, (5) Ongoing Programming and (6) Institutionalized Programming. Levels were self-reported by TMAs. Criteria for the level of outreach are detailed below:

#### (1) Contact made

- Contact key players (dialogue, email exchange, conference call)
- Discuss what SRTS is and what TMAs can do to help

#### (2) Preliminary conversations

- Present to larger groups about SRTS
- Discuss getting a Resolution of Support, setting up events, conducting surveys and tallies,
   School Travel Plans, etc.

#### (3) Setting up a program

• Establish a SRTS program by completing an enrollment form or memorandum of understanding, discussing dates for the event(s) and getting a Resolution of Support from local municipal government and local Board of Education (or equivalent body).

#### (4) In the process of program implementation

- Start annual traditions and build SRTS awareness
- Identify a SRTS champion
- Hold at least one SRTS program or event such as
  - Walk to school day
  - Bike clinic
  - School assembly

#### (5) Ongoing programming

- Get Sustainable Jersey, Sustainable Jersey for Schools and/or SRTS Recognition Program (Bronze, Silver, Gold) certified
- 4 SRTS events planned
- Create a School Travel Plan
- Conduct SRTS student travel mode tally
- Hold a multi-week program such as
  - Walking School Bus
  - Golden Sneaker program
  - Walking Wednesdays
  - Multi-day bike/pedestrian education

#### (6) Institutionalized programming

- SRTS program is part of the school identity and SRTS events implement with little to no involvement from the TMA.
- Support from PTA, PTO, or Green Team and frequent and regularly scheduled programs (more than 4 on weekly, monthly, and annual basis).

#### Pedestrian and Bicycle Events from January-December of 2019 and 2020

The number of pedestrian and bicycle events taking place in the service area was tabulated in a table. Events include walking school bus, bike train, Walk to School Day, Bike to School Day, bike rodeo, and mileage clubs.

#### Education Events from January-December of 2019 and 2020

The number of educational events was presented in a table. Examples include bike safety lessons, pedestrian safety lessons, and other related school assemblies.

#### Policy and Planning Activities from January-December of 2019 and 2020






The number of other events was presented in a table. Examples include crossing guard appreciation, community presentations and other events not listed on the Record of Contact.


#### **Outreach Level Maps for each TMA**

# 2. Training

To foster the use of best practices throughout the State, the NJ SRTS Resource Center develops, coordinates, and facilitates training programs for SRTS Regional Coordinators. These training opportunities offered throughout the year help to ensure that SRTS Regional Coordinators are well-informed about SRTS programming and help to establish consistency throughout the State. Training events offer opportunities for the SRTS Regional Coordinators to share their experiences and learn from one another through discussions to explore barriers and opportunities to SRTS program expansion, how to overcome the barriers and how to leverage the opportunities. Below is a description of trainings developed, based on priorities set by NJDOT, that were coordinated for TMA staff throughout 2019 and 2020.

#### **2019 Trainings:**

#### Peer-to-peer Learning Sessions

In these sessions, each TMA is asked to provide a short overview of one of their TMAs successful SRTS initiatives. This can be a SRTS project, program, or something innovative you have come up with. This can also be a fresh approach to a common activity or a new partnership that has been especially fruitful. Presentations include information on how the project/program/partnership works, what went well and what didn't, what was learned, and what aspects are the most effective and why. This format provides an opportunity for Safe Routes Coordinators to benefit and learn from each other's experiences and an opportunity for them to seek specific feedback from other TMAs.

#### Sustainable Jersey Assistance

Staff organized a learning opportunity where representatives from Sustainable Jersey and Sustainable Jersey for Schools discussed their programs and the coordination between the Sustainable Jersey and SRTS programs. Through aa partnership, the NJ Safe Routes to School Recognition Program, Sustainable Jersey, and Sustainable Jersey for Schools certification programs all reward actions that help make communities more walkable and bikeable. Municipalities and Schools that meet the requirements for the NJ Safe Routes Recognition Program can also earn points toward Sustainable Jersey and Sustainable Jersey for Schools certification.

#### Complete and Green Streets Model Policy & Guide

The Complete and Green Streets Model Policy & Guide is one-stop resource for New Jersey municipalities, counties, agencies, organizations, and advocates with an interest in implementing Complete Streets in their communities. The elements of this Model Complete Streets Policy sharpen the focus on implementing comprehensive Complete Streets policies, incorporating Green Streets and green stormwater infrastructure into Complete Streets projects and prioritizing health, equity and fairness in transportation expenditures and project selection. This training provided TMAs with an introduction to and overview of the Complete and Green

Streets Model Policy & Guide and how they can promote the Guide as a resource to partner communities and work with those communities to encourage better Complete Streets Policies.

#### Crossing Guard Training

The NJ Crossing Guard Training and Resources Program provides research-based training and tools for crossing guards and the traffic safety officers who supervise them. During this training, staff discussed laws pertaining to crossing guards and crossing guard duties and expectations. The session also explored best practices techniques for crossing guards and available Crossing Guard tools and resources that TMAs can use in coordination with partner communities.

#### NJ Safe Routes Recognition Program

The New Jersey Safe Routes Resource Center recognizes municipalities and schools (public, private, or charter) for their commitment to the Safe Routes program. Safe Routes Regional Coordinators can assist with nominations, or municipalities and schools can apply for recognition themselves. Nominees are asked to apply for recognition at one of four levels: First Step, Bronze, Silver, or Gold. This training thoroughly explores the requirements for each level of the program, necessary support documentation for each type of application, and the online application process.

#### New SRTS Coordinator Orientation and Training

As TMA SRTS staff changes and expands, it's important to make sure that new staff members have the tools and knowledge necessary to coordinate SRTS programs in their service area. The trainings covered the organization of SRTS in New Jersey and the roles of various players; meetings, records of contact, and quarterly reports; SRTS electronic resources; and key points and resource review of important SRTS training materials. All new TMA staff who attended trainings were provided with a flash drive containing key training presentations and resources that have been developed throughout the life of the NJ SRTS program. In 2019, three New SRTS Coordinator Orientation and Training events were held.

#### 2020 Trainings:

#### Roundtable Discussion – Remote Programming

To facilitate timely updates to SRTS projects and programming in the face of online only learning due to the COVID-19 pandemic, staff facilitated a roundtable discussion to present and discuss information about Distance Learning Resources, Distance Learning Lesson Plans, and existing walking and bicycling safety videos that Safe Routes Coordinators could use. Following the initial roundtable discussion, ongoing discussions were included as a part of monthly Safe Routes Coordinator meetings to share information on potential SRTS Program adaptations and Modifications as well as changing or evolving needs to continue supporting walking and bicycling effectively.

#### Best Practices and Approaches for in-house Video Production

Working with Civic Eye Collaborative, a training for TMA staff regarding best practices for inhouse video production and editing was developed. The session included tips for recording, lighting, sound, developing content, and editing and producing short videos with limited time, resources, and experience.

#### Best practices for Livestreaming

Working with Civic Eye Collaborative, a training for TMA staff regarding best practices for livestreaming developed. The training covered internet access and quality, camera needs, appropriate backgrounds and lighting, audio and microphone needs and set up, effective presenting techniques, the "pros and cons" of various platforms, and troubleshooting common issues.

#### • TA Set-Aside Grant

This training session provided TMAs with information about the Transportation Alternatives (TA) Set-Aside Program grant program and the application process. The session included an overview of Federal Aid programs and the TA Set-Aside Program, a detailed review of the TA Set-Aside application and grant requirements, an overview of the grant application process, and a review of grant Resources, tips and strategies that TMAs can promote to partners to help them make their grant applications stronger. In addition to the TA Set-Aside Program, other grants and funding opportunities for bicycle and pedestrian projects were also discussed.

#### NJ Safe Routes Recognition Program

Due to restrictions imposed by the ongoing COVID-19 Pandemic, NJ Safe Routes Recognition Program requirements were adjusted to make sure that they remained achievable while distance learning and social distancing were in place. While the same basic requirements remained consistent, under the adjustment a broader category of events was considered with the goal of making requirements achievable, yet still challenging. I have attached two updated fliers as well as a document that explains the changes and adjustments that have been made. The 2020 training highlighted the changes while thoroughly exploring the requirements for each level of the program, necessary support documentation for each type of application, and the online application process.

#### New SRTS Coordinator Orientation and Training (4)

As TMA SRTS staff changes and expands, it's important to make sure that new staff members have the tools and knowledge necessary to coordinate SRTS programs in their service area. The trainings covered the organization of SRTS in New Jersey and the roles of various players; meetings, records of contact, and quarterly reports; SRTS electronic resources; and key points and resource review of important SRTS training materials. All new TMA staff who attended trainings were provided with a link to a Rutgers Box file containing key training presentations and resources that have been developed throughout the life of the NJ SRTS program. In 2020, four New SRTS Coordinator Orientation and Training events were held.

# 3. Performance Measures

The NJ SRTS Strategic Plan Update identified a mission and vision for the program as well as goals and performance measures to reflect the growth and success of the program.

#### The NJ SRTS goals include:

- **Goal 1:** Educate and encourage students, parents, community members, schools, enforcement agencies, and municipalities to enhance their knowledge of safe walking and bicycling practices, increase the level-of-comfort with walking and bicycling to school, and improve the rates of walking and bicycling to school.
- Goal 2: Improve the health of school populations, communities, and the environment.
- **Goal 3**: Nurture strong partnerships and empower a network of leaders around the state to advocate for actions and policies that encourage SRTS.
- Goal 4: Promote and implement engineering strategies to support the SRTS program.
- Goal 5: Create and provide state-of-the-art tools, resources, and research to further SRTS.
- Goal 6: Sustain the SRTS program into the future, even in the face of uncertain funding.
- Goal 7: Monitor and evaluate the SRTS program's reach and effectiveness.

A total of 52 performance measures for these Goals were identified. Sources for this data include Transportation Management Associations, the New Jersey Bicycle and Pedestrian Resource Center, Sustainable Jersey, NJDOT, and VTC. VTC organized the performance measures into four categories:

- (1) Those measures currently monitored;
- (2) Measures requiring minimal additional effort to gather information;
- (3) Measures that would be assessed through a short term project; and
- (4) Measures requiring development of a new study.

For this update report, five performance measures of those currently monitored were tabulated and reported on the spreadsheet for 2019 & 2020 (see Page 82) to reflect the integration of SRTS and related goals in municipalities across NJ as indicated in the sheet. NJ SRTS Recognition Program recipients, both schools and municipalities that have attained Gold, Silver and Bronze status are also reflected on page 88. School Travel Plans that have been reviewed and approved by NJDOT are reflected on page 99. School Travel Plans completed within five years are considered current; those older than five years are no longer current and must be updated. ## **Conclusion**

2020 marked the ninth full year of the expanded New Jersey SRTS Program and partnership between NJDOT, the NJ Safe Routes Resource Center, and all eight of New Jersey's Transportation Management Associations. Throughout this program, an importance has been placed upon ensuring that Safe Routes to School is a program for everyone, and that our state's disadvantaged communities receive equal benefit from the program.

During these past nine years the program has seen and persevered through a number of developments and challenges, but no challenge has been quite as significant as those brought by COVID-19 Pandemic which closed our schools and shuttered our communities starting in March 2020. Partnerships and programs were tested, while TMA Safe Routes Coordinators were challenged to meet new demands and maintain our high level SRTS programming by being more flexible and more innovative than ever before. Adapting to the changing pandemic-world was not easy, but in the end great strides were made. From digitized programming to the development of remote learning resources, Safe Routes Coordinators updated lessons and programs to function remotely while still meeting the educational needs of the students, schools, and communities they serve.

Performance measures identified as part of the NJ Safe Routes to School Strategic Plan have been used to evaluate and reflect upon the growth and success of the continuing program. As of December 2020, there were: 115 completed school travel plans, 138 Complete Streets Policies adopted, 53 completed SRTS Actions for Sustainable Jersey, nine completed Adopt Complete Streets actions for Sustainable Jersey and two Implement Complete Streets actions for Sustainable Jersey, and 115 SRTS Infrastructure grants awarded.

Outreach between 2019 and 2020 has remained relatively consistent across all tracked measures. The number of Low Socioeconomic Status Communities contacted increased between 2019 and 2020 at a rate of 35%, while the total outreach at all levels has increased by 16% between 2019 and 2020. There has also been an increase in the number of completed School Travel Plans from throughout the State. Completing school travel plans requires a significant effort on the part of the TMA and the partner communities they are working with. Though they require significant effort, high quality school travel plans are vital to the continued success of SRTS programs as they visualize for the future, help organize funding priorities, and enhance the sustainability of local programs.

Though significant progress has been made, there is still much to be done. SRTS Regional Coordinators at each TMA will continue to promote and implement SRTS programs in their service areas guided by training, oversight, and technical assistance informed by continued research from the NJ Safe Routes Resource Center. Using national best practice research and relying on the lessons learned through past success, the New Jersey SRTS Program will continue to grow as we seek to reach out to and partner with

additional schools, local and regional governments, and other organizations to provide SRTS programs and services, ensuring that inclusion of disadvantaged communities remains a core program priority.
